OVERT ACT !

OVERT ACT II

On March 7th 2016 Officer Brian Bunton contacted Jasmine via text and encouraged and promoted acts of prostitution by asking her if she "made all her money" and then informed her that she "needed a better manager" when Ms. A stated she did not make as much money as she wanted.

SECOND COUNT

The undersigned further deposes and says on information and belief, that said BRIAN BUNTON did, in the County of Alameda, State of California, on or about March 5, 2016, commit a MISDEMEANOR, to wit: ENGAGING AND AGREEING TO ENGAGE IN PROSTITUTION, a violation of section 647(b) of the PENAL CODE of California, in that said defendant(s) did unlawfully engage in and agree to engage in an act of prostitution and did some act within this state in furtherance of an act of prostitution.

NOTICE: Conviction of this offense will require the court to order an AIDS test pursuant to Penal Code Section 1202.6.
