re: FREEDOM OF INFORMATION REQUEST about Big Wind vehicles for the City of Santa Cruz

Dear U.S. Army FOIA Officer:

I am writing to assist the City of Santa Cruz to "blow the leaves": a term for chasing (disabled) homeless people out of town.

Since the Santa Cruz City Council, their staff and the Santa Cruz Police Department (SCPD) want to cleanse Santa Cruz of (disabled) homeless people — my sister Patricia Colby and I were recently made homeless by them and the state/federal government — I have decided it's best to be on the winning side (which uses a hate filled narrative to control the populace).

Cleansing cities of (disabled) homeless people has been termed by them as "blowing the leaves" or "not feeding the cats".

The SCPD, the City Council and their staff have violated the civil rights of (disabled) homeless people and aided and abetted the domestic terror group Take Back Santa Cruz (TBSC) to help them run homeless people out of town to the point of killing them. Since they are all so incompetent in implementing their hate fueled agenda against (disabled) homeless people as a collective group, I would like to assist them as a Ph.D. in computer science to "get the job done" right.

It has come to my attention that the U.S. Army employs what is essentially a huge leaf-blower to put out well fires in



Kuwait and Iraq called "Big Wind". I want to help the City of Santa Cruz acquire some of these military vehicles to commit outright genocide against (disabled) homeless people and rid the City of them ASAP.

Under the FOIA I make the following FREEDOM OF INFORMATION request. I ask for:

1. The most current electronically available (non-classified) military specifications for the latest "Big Wind" devices employed by the U.S. Army. See this: <http://www.badassoftheweek.com/index.cgi?id=652736728443>
2. I also ask for the most current electronically available promotional brochures and documents for the "Big Wind" military vehicle and how the City of Santa Cruz may apply for a federal grant to purchase and maintain several of these.

I am willing to pay fees up to \$35 although I ask for a waiver of fees. If the costs will exceed this, I ask I be given a fee estimate before the request is even worked upon further. I ask that all electronically available records be provided to me in their native formats or as hyperlinks to them on the Internet. However, I believe disclosure of the requested information to me is in the public interest because it will likely contribute significantly to public understanding of the operations or activities of the government and is not primarily in my commercial interest.

Specifically, I intend to share this material with the DOD IG, the NIC IG, the FBI, the USDOJ, Congress, President Obama and the news media to whom I have carbon copied this request, nonprofit (legal) advocacy organizations for their dissemination of information — and to learn how they may better serve their constituents/clients — about how the U.S. military has the means to help the City of Santa Cruz to commit genocide against (disabled) homeless people.

I ask as a Section 504 reasonable disability accommodation that you waive all fees because HUD, the USDOJ, TIGTA OIG and HUD OIG all made us homeless, impoverishing us and exacerbating our disabilities to the point of death as documented by our physicians.

Copies of the requested records will go to the President, the U.S. Senate, the FBI, the USDOJ, the CADOJ, Kamala Harris, Governor Jerry Brown's office and local attorney's to litigate against the City's criminalization campaign against (disabled) homeless people. This is not primarily on my commercial interests while it is very much in the right of the public to bear witness to this.

I'm writing to the carbon copied news media and to legal advocacy to protect the human and civil rights of disabled homeless people. I don't want them killed, I only want to expose the City and TBSC's hate filled agenda exposed

Since TBSC claims all homeless people are dangerous criminals, we might as well just kill them all: it worked for Hitler.
