Dear Sheriff-Coroner Jim Hart:

My sister and I are being gang stalked by the domestic hate group Take Back Santa Cruz (TBSC) on basis of disability, gender and in retaliation for helping disabled homeless people exercise their civil rights. Many of these gang stalkers claim to carry firearms. Many of them live and commit their crimes from your jurisdiction. For example, we have determined that the sexual predator cyberstalking us on the Santa Cruz Topix Forums is Thomas Cunniff of Aptos, California, who stalks us from that locale. Worse, his domestic partner is Santa Cruz County probation officer Julia Feldman, who has also cyberstalked us from that locale.

Consider the website TBSC uses to stalk us: www.johncohencolby.com — we have determined the website was created by Scotts Valley resident Steve Schlicht colluding with other TBSC members in your jurisdiction like Thomas Cunniff and Julia Feldman. When TBSC made death threats against us and our emotional assistance cats on the day we were fraudulently made homeless — September 1, 2016 — the FBI instructed me to contact the Santa Cruz Police Department (SCPD) to investigate these crimes. The SCPD refused to investigate; the FBI then instructed me to contact your agency to have your agency investigate these crimes. Your deputies refused: like the SCPD they defied the FBI.

Questions:

1. Why is your agency defying the FBI?
2. Why won't you investigate the gang stalking campaign against us by TBSC which is occurring in your jurisdiction?
3. Why are you protecting TBSC and Santa Cruz County probation officer Julia Feldman, thus committing treason per federal statute?

Thank you for finally answering our questions instead of denying us service under color of law, ignoring the hate crimes against us by TBSC, Thomas Cunniff and Julia Feldman.
